Upon arriving at the Senate Desk in Koldus at approximately 12:15pm April 24th, 2014, Mr. Russo saw several bills that had been delivered to Senate by the Executive Branch, presumably the previous evening. Two such bills, S.B. 66-78 The "Football Only" Sports Pass Option Bill and S.B. 66-74 The Board of Regents Fee Accountability Bill, were stamped with a "VETO" stamp on the signature line for

the Student Body President. Neither of these veto stamps were initialed or dated. Mr. Joseph was present in the SGA Office, so Mr. Russo inquired about the vetoed bills. According to Mr. Joseph, who was out of town at the time of the Special Session and General Assembly Meetings on April 24th, 2014, he had directed a proxy to veto these bills before the 66th Session adjourned during Joint Session. Mr. Russo then informed Mr. Joseph that this action was forbidden by the Constitution. At 2:28 pm, Mr. Russo sent Mr. Joseph a citation of the SGA Constitution to this effect. At the time of writing, Mr. Russo had not received any response.Because Mr. Russo and the others cited on this appeal believe this veto to be in direct violation of the SGA Constitution, the former Speaker and bill authors felt it necessary to file an appeal with the Judicial Court.
