The plaintiff claims that the Election Commission neglected their duty to properly and fairly enforce the Texas A&M Student Government Association Election Regulations (Chapter 601 of the Student Government Association Code, henceforth to be referred to as the "Election Regulations").

On Wednesday, February 18, 2015, a video entitled "Go(Pro) with Joe" was uploaded by Chase Roberts, an agent of the campaign of Student Body President candidate Joseph Benigno

This video contains evidence of several violations of the Texas Transportation Code and evidence of Off-Campus Campaigning, which in turn are violations of Article VI, Section c., Subsection i.i.a. Major Offenses of the Election Regulations. Additionally, the video contains evidence of several violations of Article VI, Section c., Subsection i.ii.a. Minor Offenses of the Election Regulations.

Violations of the Texas Transportation Code (Major Violations) include:

- Sec. 544.010 Failure to Stop at a Stop Sign (0:05-0:06)
- Sec. 661.003.(a) Operating a Motorcycle without a helmet under the age of 21
- Sec. 545.416.(b) Transporting Passenger on Motorcycle not Equipped with Seat for a Passenger
- Sec. 545.302.(a)(2) Parking a Motorcycle on a Sidewalk (0:28-0:30)
- Sec. 545.422.(a) Driving a Motorcycle on a Sidewalk (1:30-1:47)
- Sec. 545.055(b) Driving on left side of the roadway in a no-passing zone (2:08-2:10)

Violations of Texas A&M Transportation Services Parking Rules & Regulations(http://transport.tamu.edu/Parking/regulations.aspx) include:

• Parking Moped in a Non-Designated Area (1:05-1:06)

Violations of the Election Regulations include:

- Article V, Section b., Subsection iii. Display of Campaign Materials Off-Campus 3 instances
- Article V, Section b, Subsection xiii. More than 4 people campaigning in one place 2 instances

On Thursday, February 19, 2015, the Election Commission fined Student Body President candidate Isaiah Tsau for two major violations for "Campaining in Off-Limit Areas," totaling \$500 in fines. Due to this precedent set by the Election Commission, any violations for Off-Campus Campaigning should be considered Major Violations.

On Thursday, February 19, 2015, all of the aforementioned violations were submitted to the Election Commission between the hours of 11:30am and 6:00pm Central Standard Time by Texas A&M Students Carlos Sonka, Aubre Dean, Austin Springer, Aaron Mitchell, Austin Henderson, Fernando Sosa, Lauren Felder, Zach Carlson, Katrina Lack and Chris Woolsey. Of these reported violations, fines were issued only for the two instances of violations of Article V, Section b., Subsection xiii. At the date of this appeal, no written explanation has been given as to why no fines were issued for the other Major and Minor Violations.

Constitutional/Statutory Citations

Texas A&M Student Government Association Election Regulations (Chapter 601 of the Student Government Association Code), with particular attention given to the following passages:

Article V, Section b., Subsection iii. Display of Campaign Materials Off-Campus

"iii. Off-campus campaigning shall be prohibited. No campaign materials shall be distributed, posted, or held off campus."

Article V, Section b., Subsection xiii. More than 4 people campaigning in one place

"xiii. Only four (4) people working for one candidate or any mutually supportive group of candidates may campaign in one place at a time. This does not include the candidate or group of candidates themselves."

Article VI, Section c., Subsection i.i.a. Major Offenses

"a. Major offenses. Major violations include, but are not limited to: offenses against local, state or federal law to any degree; sabotage of opposing campaigns; voting fraud, falsified documents (including finance reports); withheld finance reports and ethics/Honor Code violations."

Article VI, Section c., Subsection i.ii.a. Minor Offenses

"a. Minor offenses. Minor violations include, but are not limited to: pre-campaigning, finance violations, and offenses not included within the major violations criteria as determined by the Election Commission and these regulations."

Special Circumstances (If Applicable)

The plaintiff requests injunctive relief, specifically that the Chief Justice refrain from certifying the Spring 2015 Student Body President election results until this case is resolved.

Additionally, the plaintiff requests Clayton Cromer as Judicial Advocate.

What would you like the Court to do to rectify the harm that you have faced in your appeal?

The plaintiff seeks that Student Body President candidate Joseph Benigno be fined in the appropriate amount for each violation cited in the Facts section above, and that these fines should be applied to his total campaign budget.
